MEETING SUMMARY

1. CALL TO ORDER AND SELF-INTRODUCTIONS

Vanessa Schoenewald, TCWG Chair, called the meeting to order at 10:02 a.m.

2. PUBLIC COMMENT PERIOD

None.

3. CONSENT CALENDAR

- 3.1. January 28, 2025 TCWG Meeting Minutes
The meeting minutes were approved.

4. INFORMATION ITEMS

4.1. Reviews of PM Hot Spot Analysis Interagency Review Form (10 minutes)

- **Attachment 4.1-1: Request Letter for SCAG Quick-Build Transportation Safety Projects:** it was determined that these projects are exempt and can be programmed into SCAG's FTIP.

The concurring agencies noted that for these types of exemption requests they appreciated this format of combining information for all projects into one presentation in lieu of filling out individual PM Hot Spot Analysis Interagency Review Form for each submittal.

The concurring agencies also noted that when using the hazardous location or feature exemption under the safety category (see 40 CFR Section 93.126), a quantitative method such as collision data is required.

4.1.1. PM Hot Spot Interagency Review Forms Presented at the January 28, 2025 TCWG Meeting (For Public Notice Purposes)

- **RIV160405 (refer to January 28, 2025 TCWG agenda and attachments):** it was determined that this project is not a project of air quality concern.
- **RIV170901 (refer to January 28, 2025 TCWG agenda and attachments):** EPA staff requested additional review time. Therefore, no TCWG concurrence was provided at the meeting. It was reiterated that no email concurrence could be provided and requested that SCAG include this project in the March 2025 TCWG meeting agenda.

4.2. RTP Update

4.3. FTIP Update

Agustin Barajas, SCAG, reported the following:

- 2025 FTIP Amendment #25-03 was undergoing a 10-day public review period and would subsequently be submitted for state and federal approvals.
- 2025 FTIP Amendment #25-04 was expected to be approved by late February 2025.
- Future opportunities for projects modifications included 2025 FTIP Amendment #25-05 and 2025 FTIP Amendment #25-06, which would be due March 11 and March 18, 2025, respectively.

Michael Morris, FHWA, stated that FHWA approvals of regional transportation conformity determinations for FTIP amendments would require reviews through the Office of Chief Counsel in Washington D.C. This new process would cause a potential delay.

- CARB staff continued to develop the EMFAC2025 model, with a finalized model and a public workshop planned for March 2025. The new emissions model would be submitted to U.S. EPA for approval anticipated in Summer 2025.
